* Double major programs are structured so that students have at least 18 local credits for associate degree programs and at least 36 local credits for bachelor's degree programs; the total number of ECTS credits from equivalent courses and courses taken from the second major program is 120 for associate degree programs, 240 for four-year bachelor's degree programs, 300 for five-year bachelor's degree programs and programs with arts preparatory courses, and 360 for six-year bachelor's degree programs.
